An Assessor Course is planned for September 2011.

Assessor Course:

The Assessor course will be held on the following dates, venue TBC:

- Saturday 24 September 2011, 9.00am – 5.00pm
- Sunday 25 September 2011, 9.00am – 5.00pm

**Candidates wishing to take part in this course must attend BOTH of the dates listed above.*

Numbers are strictly limited for this course, so if you have any likely assessors in your club, please encourage them to enrol by Friday 16 September 2011.

As per SLSA standards, all persons seeking to obtain their Assessor qualification are required to have successfully completed the three (3) units of competency:

- TAEASS401A Plan assessment activities and processes
- TAEASS402A Assess competence
- TAEASS403A Participate in assessment validation

before they can commence assessing any SLSA award. All assessment requests now require Assessor names to be recorded in SurfGuard.

Prerequisites:

Candidates for this course must fulfil the following requirements:

- Be a registered member of an SLSSA club
- Be at least 18 years old
- Hold the award for the discipline they wish to assess. e.g. Bronze Medallion
- Hold the Training Officer certificate for the discipline they wish to assess e.g Training Officer Bronze Medallion

Course details:

The course will cover the requirements for the three assessor units of competency that SLSA and RTO guidelines now require that every SLSA Assessor holds.

Upon completion of this course and the associated assessment activities, participants will be awarded a nationally recognised statement of attainment from the TAE40110 Certificate IV in



Training and Assessment:

- TAEASS401A Plan assessment activities and processes
- TAEASS402A Assess competence
- TAEASS403A Participate in assessment validation

Note: Assessors are only required to attend an assessor course once.

Recognition of Prior Learning:

Individuals who have previous assessing experience, or hold the Assessor Certificate but do not hold a formal assessor qualification (the three nationally recognised units of competency) are encouraged to apply for recognition of prior learning. Assessors wishing to be exempted from the course due to prior learning must apply to SLSSA; a RPL document is available on request from Joy Fisher, Academy Manager.
