Expressions of interest are being sought for athletes to be part of the 2009/10 High Performance Program. The High Performance Program has been re-designed to build a structure and systems in order to produce top level surf lifesaving athletes in South Australia now and in the future. One of the greatest honors an athlete can receive is to be selected to represent their State in competition. Participation in the program can lead to State Team and State Development Team selection.

Any athlete who placed in the top three positions in the 2009 State Championships in relevant events will receive their own invitation.

In addition we will allow wild card entries. These are for athletes who did not place in the 2009 State Championships but may have the necessary attributes to be considered for inclusion. Expressions of Interest for these wild card entries are now being called.

To begin the program and provide all the information that athletes require, a forum will be conducted on **Tuesday 22nd September 7.00 pm at the Glenelg SLSC**. At the forum we will provide information on:
