ENTRIES:

All entries are to be electronically entered into SLSSA **Events Management System**.

Names only are required and teams can be sorted on the day.

A separate email has been sent to all Club Captains and Competition Officers with details of how to use this system.

NOMINATION FEES:

As this event is not formally part of the State Championship events, **please note that a nomination fee of \$5.00 per competitor (\$15.00 late entry)** will apply for the Board and Ski events. These will be accounted for through the clubs after the close of entries and therefore no fees need accompany nominations. All competitors must be proficient and financial and be the holder of the appropriate award.

COMPETITION CONDITIONS:

Events will be conducted in accordance with the Surf Sports Manual – 33rd Revised Edition (August 2010), and associated Bulletins issued by Surf Life Saving Australia from time to time. Further information of the Rules may be obtained from the SLSA website:

EVENTS TO BE CONDUCTED: All Relay events (3 per team)

Should numbers be sufficient all age categories will be conducted e.g. Board only U/15 M&F. Board and Ski for U/17 M&F, U/19 M&F, Open M&F and Masters M&F. Composite teams and NGS teams will be permitted for clubs that do not have enough competitors to make teams. If there are enough teams there will be graded races A, B, C etc.

EVENTS

- Board Relay
- Ski Relay
- Double Ski races

MARSHALLING:

All events will **ONLY** be marshalled when the Referee determines that the event is about to proceed.

Should an event be cancelled or rescheduled once it has started, only those marshalled competitors will be permitted to continue when the event restarts.

This means that any competitor legitimately entered and who was unable to attend at a previously cancelled event **will be** permitted to compete, unless that event had been previously marshalled.

In the event of poor conditions, a backup venue or date will be determined by the event referee to ensure the safety of all concerned.

USE OF HIGH VISIBILITY LYCRA RACING VESTS FOR BOARD AND SKI SERIES EVENTS

As outlined in Bulletins B11008 and B11007, it was agreed that high visibility vest are to be used at senior events in South Australia this season especially when conducted in surf conditions.

More specifically, in regards to the Board and Ski Series events, this ruling means that it will be compulsory to wear a high visibility lycra racing vests to participate in these events. A number of prototype vests have been purchased and will be 'triallyed' at this Board and Ski events.

These prototype vests will be available for \$5.00 to all competitors at the Board and Ski event. If competitors have a vest from the 2011 Australian Championships or from the Ocean Paddling Series these can be worn.
